The Ministry of Public Works and Transport (MPWT) of Lao PDR has received financial support from the World Bank's (WB) and the Nordic Development Fund (NDF) to implement Lao Road Sector Project 2 (LRSP2) (March 2017-August 2022), which will support MPWT strengthen its capacity at both central and local levels to manage local road improvement and maintenance. The MPWT will be the Executing Agency (EA) for LRSP2. A project management team formed under The Department of Planning and Finance (DPF), MPWT will provide overall project coordination and monitoring. The project has included support to strengthen capacity of department concerned in MPWT and provinces. Department of Planning and Finance (DPF) will be responsible for providing procurement support to the concerned departments, Department of Roads (DoR) with support from design and supervision consultant is responsible for managing the road works and road asset management systems development.

The LRSP2-AF project, MPWT seeks a full-time the 3 Road Maintenance Engineer (RME) position to be based in Oudomxay, Xayabouly, and Bolikhamxay province and assist DoR and DPWT Oudomxay, Xayabouly, and Bolikhamxay province in Detailed Design, Implementation Supervision and Support of Climate Resilient Road Maintenance/Rehabilitation Works and strengthen the capacity of DoR/MPWT and DPWTs in planning and management of local road network.

This shall be a full-time assignment with a total estimated time input of 19 months consultancy service period, with possibility of renewal based on satisfactory performance review and Project needs. The assignment is planned to start in June 2024. The LRSP2-AF Project, MPWT now invites eligible individual consultants to indicate their interest in providing the Services. Interested Consultant should provide information (CV, Expression of Interest, other supporting information, if any) demonstrating that s/he has the required qualifications and relevant experience to perform the Services. In order to qualify for this position, the candidates shall meet the following experience and competence requirements:

- At least Bachelor's Degree in one of following areas of academic qualification: engineering / transport / procurement / economics / business administration or other relevant discipline;
- Minimum 5 years of relevant working experience in transport sector. Work experience in developing countries and in the region is an advantage;
- At least 1 assignment performed in the capacity of Road Maintenance Engineer or similar expertise within the past 5 years;
- Experience of working in road construction / maintenance projects; Such experience or working under performance-based contracts (PBC) is an asset;

- Familiarity with national design standards and guidelines for periodic and routine road maintenance and other relevant legislation;
- Experience in public procurement in projects financed by development partners (e.g. WB, ADB, EU etc.);
- Excellent in speaking and writing in English; Knowledge and proficiency in Lao language is mandatory;
- Computer proficiency (Windows, MS Office, Databases); Skills in using the Provincial Road Maintenance Management System (PRoMMS) is an advantage.
